Since August 2014, Sonning Common Library has been run with the help of enthusiastic volunteers. The team supports the professional staff by, among other things, shelving books, running story-times, helping customers and delivering books to people in the community.

The cuts to Oxfordshire County Council's Libraries budget, which made it necessary to find volunteers to help run the library, continue to threaten our Library.

The Central Library book fund has been reduced and the separate Library Manager's book fund no longer exists. FoSCL is raising funds to make up the shortfall and provide other much needed resources.
